Municipal Code Relating to Parking Fees)

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAFAYETTE DOES ORDAIN AS
FOLLOWS:

Section 1. Amendments.

Section 8-8165 of the Lafayette Municipal Code is hereby amended to read as follows:

“8-8165 Parking fees.

- (a) The charge for the use of a metered parking space in the parking meter zone shall be established by resolution of the city council.
- (b) The charge for the use of a numbered parking space corresponding to the numbered slot on a parking lock box shall be established by resolution of the city council. No person using a numbered parking lock box space shall place less than the amount due for the use of such space as established by resolution of the city council, regardless of the number of hours used between the hours of six a.m. and six p.m., excluding Saturdays, Sundays and holidays. The parking lock box shall accept only exact currency.”

Section 2. CEQA. The City Council hereby finds and determines that this Ordinance is a modification of rates by the City for the purpose of meeting the financial reserve needs of the City consisting of the operation of existing facilities. Therefore, the adoption of this Ordinance is exempt from the requirements of the California Environmental Quality Act (“CEQA”) pursuant to Sections 15273 (a) and 15301 of the CEQA Guidelines.

Section 3. Notice of Exemption. The City Council directs staff to prepare and file a Notice of Exemption no more than five (5) working days after adoption of this Ordinance.

Section 4. Effective Date. This Ordinance becomes effective thirty (30) days after its adoption.

Section 5. Severability. If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance, or any part thereof is for any reason held to be unconstitutional, invalid or ineffective by any court of competent jurisdiction, such decision shall not effect the validity or effectiveness of the remaining portions of this Ordinance or any part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance irrespective of the fact that one or more sections, subsections, subdivision, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective. To this end the provisions of this Ordinance are declared to be severable.


