The Banner Advisory Committee (BAC) develops the downtown street pole banner program that will provide for the announcement and promotion of special events that will occur in Lafayette, be sponsored by Lafayette civic groups and be of predominate civic content and interest to citizens and residents of Lafayette. In carrying out its duties, BAC shall insure that the banners are attractively designed, add color, vitality and design elements to downtown Lafayette, are consistent with downtown design aesthetics and conform with the guidelines that have been set.

Requirements/Qualifications: A public art committee will be appointed by the city council. This committee will be composed of individuals who, by experience, training, education, occupation or avocation, have demonstrated knowledge of and interest in the visual arts. The committee will advise the city council in matters pertaining to public art acquisitions and gifts, artwork maintenance, and, when necessary, artwork de-accession. The committee will serve as steward of the

city collection. The committee shall hold regular meetings, at least every three months, that are open to the public and at such times and places as it shall determine.
