This project shall be constructed in accordance with the <u>March 2013</u> edition of the City of Lafayette Standard Specifications, which may be obtained at the City of Lafayette Engineering Services Division. The cost of the Standard Specifications is \$20 per set. The cost of mailing is an additional \$8. If you already have the Standard Specifications (dated <u>March 2013</u>), you do not need to purchase a new copy.

Bids shall be submitted in a sealed envelope titled "Proposal: City of Lafayette, 2014 Crack Fill Contract, Project No. 014-9698CF".

The Contractor shall possess a Class "A" license at the time this contract is awarded.

Bidder's attention is directed to requirements in Sections 2 and 3 of the Standard Specifications General Provisions.

Bid bond, performance bond, and payment bond are not required for this contract.

The City of Lafayette reserves the right to waive any informalities or to reject any or all bids.

The City Council has ascertained the General Prevailing Rates of Wages applicable to this work, and these rates are on file in the office of the City of Lafayette Engineering Services Division.

CONTRACT AGREEMENT FOR CONSTRUCTION

THIS AGREEMENT is made and entered into as of	, 2014, by and between the CITY
OF LAFAYETTE ("City") and	("Contractor").

RECITALS

- A. City desires to retain the services of Contractor to provide services for Construction of City of Lafayette, 2014 Crack Fill Contract, Project No. 014-9698CF, including, but not limited to: mobilization; traffic control and construction signage; cleaning, routing, and filling pavement cracks; and all other work as shown in the Contract Documents to provide a complete project.
- B. Contractor has represented to City that it has the expertise, experience and qualifications to perform the services described in Paragraph A, above, and those services which are more fully described below.

NOW, THEREFORE, in consideration of the foregoing and the covenants and agreements set forth below, City and Contractor agree as follow:

- 1. <u>Contract Documents</u>. The contract documents for the aforesaid project shall consist of the Notice to Contractors, Bid Proposal, General Provisions, Technical Provisions, Special Provisions including appendices, Design Drawings, and all referenced specifications, details, standard drawings, and their appendices; together with this Contract Agreement and all required bonds, insurance certificates, permits, notices and affidavits; and also including any and all addenda or supplemental agreements clarifying, amending, or extending the work contemplated as may be required to insure its completion in an acceptable manner. All of the provisions of said contract documents are made a part hereof as though fully set forth herein.
- 2. Services. For and in consideration of the payments and agreements to be made and performed by City, Contractor agrees to furnish all materials and perform all work required for the above-stated project, and to fulfill all other obligations as set forth in the aforesaid contract documents. Contractor agrees to receive and accept the prices set forth in the Proposal as full compensation for furnishing all materials, performing all work, and fulfilling all obligations hereunder. Said compensation shall cover all expenses, losses, damages, and consequences arising out of the nature of the work during its progress or prior to its acceptance including those for well and faithfully completing the work and the whole thereof in the manner and time specified in the aforesaid contract documents; also including those arising from actions of the elements, unforeseen difficulties or obstructions encountered in the prosecution of the work, suspension or discontinuance of the work, and all other unknowns or risks of any description connected with the work.
- 3. Employment by City. City hereby promises and agrees to employ, and does hereby employ, Contractor to provide the materials, do the work, and fulfill the obligations according to the terms and conditions herein contained and referred to, for the prices aforesaid, and hereby contracts to pay the same at the time, in the manner, and upon the conditions set forth in the contract documents.
- 4. <u>Worker's Compensation</u>. Contractor acknowledges the provisions of the State Labor Code requiring every employer to be insured against liability for worker's compensation, or to undertake self-insurance in accordance with the provisions of that Code, and certifies compliance with such provisions. Limits

shall be not less than those specified in the insurance requirements contained in the General Provisions of the Standard Specifications, and as modified in these Special Provisions.

- 5. <u>Insurance</u>. With respect to performance of work under this contract, Contractor shall maintain and shall require all of its subcontractors to maintain insurance as required in the General Provisions of the Standard Specifications, and as modified in these Special Provisions.
- 6. <u>Indemnity</u>. Contractor shall comply with the indemnification requirements contained in the General Provisions of the Standard Specifications.
- 7. <u>Assignment</u>. This contract is not assignable nor the performance of either party's duties delegable without the prior written consent of the other party. Any attempted or purported assignment or delegation of any of the rights or obligations of either party without the prior written consent of the other shall be void and of no force and effect.
- 8. <u>Non-discrimination</u>. Contractor shall not discriminate in the hiring of employees or I the employment of subcontractors on any basis prohibited by law.
- 9. <u>Independent Contractor</u>. Contractor is and shall at all times remain as to City, a wholly independent contractor. Neither City nor any of its agents shall have control of the conduct of Contractor or any of the Contractor's employees, except as herein set forth. Contractor shall not at any time or in any manner represent that it or any of its agents or employees are in any manner agents or employees of City.

- 11. <u>Authorized Signature</u>. Contractor affirms that the signatures, titles, and seals set forth hereinafter in execution of this contract agreement represent all individuals, firm members, partners, joint ventures, and/or corporate officers having a principal interest herein.
- 12. Entire Agreement; Modification. This contract supersedes any and all other agreements either oral or written, between the parties and contains all of the covenants and agreements between the parties pertaining to the work of improvements described in Paragraph A of the Recitals herein above. Each party to this contract acknowledges that no representations, inducements, promises, or agreements, orally or otherwise, have been made by any party, or anyone acting on behalf of any party, which are not embodied herein, and that any other agreement, statements or promise not contained in this contract shall not be valid or binding. Any modification of this contract will be effective only if signed by the party to be charged.
- 13. <u>Claims Procedure</u>. In the event of a dispute between the parties regarding a) a time extension demand, b) payment arising for work performed by or on behalf of the contractor which is not otherwise

expressly provided for, or c) an amount the payment of which is disputed by the City, the procedure in Section 10 of the City of Lafayette Standard Specifications shall be used.

CITY OF LAFAYETTE SPECIAL PROVISIONS

SPECIAL PROVISIONS SECTION SP-1

GENERAL (NO BID ITEM)

The work to be done under this contract, except as modified or supplemented herein, shall conform to the following:

- The City of Lafayette General Provisions of the Standard Specifications dated March 2013, herein referred to as the "General Provisions of the Standard Specifications".
- The City of Lafayette Technical Provisions of the Standard Specifications dated March 2013, herein referred to as the "Technical Provisions of the Standard Specifications".

Where specifically referred to, the work shall also conform to the following:

- The State of California Department of Transportation (Caltrans) Standard Specifications, For Construction of Local Streets and Roads, 2010 Edition, herein referred to as the "State Specifications" or "State Standard Specifications".
- The State of California Department of Transportation (Caltrans) Standard Plans, 2010 Edition, herein referred to as the "State Standard Plans".
- The Contra Costa County Public Works Department Standard Plans, most current edition, herein referred to as the "County Standard Plans".

These Special Provisions are additions, modifications, or clarifications to the referenced Standard Specifications and generally supersede the referenced or applicable sections of said Standard Specifications. Refer to Section 5-4, "Precedence of Contract Documents", of the General Provisions of the Standard Specifications for the order of precedence of Contract Documents. Where ambiguity or conflict exist in the interpretation of precedence, the provision resulting in the highest quality or most expensive grade of construction or product shall govern.

SPECIAL PROVISIONS SECTION SP-2

PLANS AND SPECIFICATIONS (NO BID ITEM)

The provisions of Section 4, "Plans and Specifications (General)," of the General Provisions of the Standard Specifications shall apply in their entirety and as supplemented herein.

SP2-01 SCOPE OF WORK

The work to be performed under this contract including, but not limited to: mobilization; traffic control, construction signage, and arrow board; cleaning, routing, and filling pavement cracks, and all other work as shown in the Contract Documents to provide a complete project.

SPECIAL PROVISIONS SECTION SP-3

PROGRESS OF WORK (NO BID ITEM)

The provisions of Section 8, "Progress of Work," of the General Provisions of the Standard Specifications shall apply in their entirety and as supplemented herein.

SP3-01 WORKING HOURS

Without prior written approval by the Engineer, and except for emergency work, work or activity of any kind shall be limited to the hours from 8:00 a.m. to 5:00 p.m. Monday through Friday. Contractor's attention is directed to Section SP6-02, "Lane Closure Hours," of these Special Provisions.

SP3-02 TIME OF COMPLETION AND LIQUIDATED DAMAGES

The Contractor shall complete the entire Work in this Contract within **twenty five** (25) working days from the start date, including completion of all "Punch List" work. Liquidated damages will not be assessed on this Contract. However, no payment shall be made for work that is incomplete or partially complete. For the purpose of determining completeness, all items in the Bid Schedule shall constitute the Contract Work as one whole. Contractor shall not be entitled to partial compensation for having partially completed said Contract Work.

SP3-03 PAYMENT

No separate payment will be made for conforming to the provisions of this section. Full compensation for conforming to all the provisions of this section shall be considered as included in the Contract Price, and no additional compensation shall be allowed therefor.

SPECIAL PROVISIONS SECTION SP-4

MOBILIZATION (NO BID ITEM)

The provisions of Section 1, "Mobilization," of the Technical Provisions of the Standard Specifications shall apply in their entirety except as modified or supplemented herein.

No project identification signs are needed for this Contract.

SPECIAL PROVISIONS SECTION SP-5

CONSTRUCTION AREA SIGNS (NO BID ITEM)

No separate construction area signs are needed, other than those required to implement traffic control as specified elsewhere in these Special Provisions.

SPECIAL PROVISIONS SECTION SP-6

(NO BID ITEM)

SP6-01 GENERAL

Work shall conform to the requirements of Section 6-12, "Traffic Control," of the General Provisions of the Standard Specifications. Nothing in these Special Provisions shall be construed as relieving the Contractor from his/her responsibilities as specified in said sections.

Prior to beginning Work, Contractor shall submit a traffic control plan for each work zone arrangement expected to occur in this Contract. No work shall proceed until the Engineer reviews said submittal.

Traffic control to close lanes on Mt. Diablo Boulevard, Oak Hill Road, and St. Mary's Road shall consist of a "moving work zone" that moves down the street as the work proceeds within the work limits. At minimum, in

addition to standard signage to delineate the overall work limits, a standard truck-mounted, electronic, flashing arrow board shall be provided to trail the moving work zone. Additionally at least two (2) flaggers shall be provided at all times. At all other locations, Contractor may propose alternative traffic control plans, which in any case shall include at least two (2) flaggers in addition to standard traffic control signage to manage traffic around the work zone.

Flaggers shall be <u>solely dedicated</u> to coordinate and direct traffic around the work zone. Workmen shall not be allowed to multi-task other work with traffic control duties.

SP6-02 ROAD/LANE CLOSURE AND HOURS

Road closures are not allowed.

Lane closure hours are limited to the following:

- 1. Mt. Diablo Boulevard, 9 a.m. to 4 p.m.
- 2. Oak Hill Road, 9 a.m. to 2:30 p.m.
- 3. St. Mary's Road, 9 a.m. to 2:30 p.m. on a day when area schools are in session; 9 a.m. to 4 p.m. on all other days.
- 4. All locations in residential neighborhoods, 8:30 a.m. to 4:30 p.m.

SP6-03 PAYMENT

No separate payment will be made for conforming to the provisions of this section. Full compensation for conforming to all the provisions of this section shall be considered as included in the Contract Price, and no additional compensation shall be allowed therefor.

SPECIAL PROVISIONS SECTION SP-7

CRACK FILL REPAIRS (BID ITEMS 1 THROUGH 9)

The provisions of Section 12-2, "Crack Fill Repairs," of the Technical Provisions of the Standard Specifications shall apply in its entirety except as modified or supplemented herein.

SP7-01 LIMITS OF WORK

The project limits are defined as follows:

Area 1 Mt. Diablo Boulevard, First Street to Carol Lane

Area 2 Oak Hill Road, Mt. Diablo Boulevard to Deer Hill Road

Area 3 Glorietta Boulevard, Woodside Court to End

Pine Lane, El Nido Ranch Road to end of public street

Area 4 Rohrer Drive, St. Mary's Road to Burnt Oak Circle

Castello Road, Rohrer Drive to Camino Colorados

Huntleigh Drive, Lucas Drive to southerly property line of Address No. 613

Beechwood Drive, end of roadway cul-de-sac to Reliez Station Road (entire road)

Area 5 St. Mary's Road (North)-

- a. Moraga Road to Hope Lane;
- b. Glenside Drive to southerly end of guard rail near driveway of Address No. 764.
- Area 6 St. Mary's Road (South), Glenside Drive/Woodview Lane to southern city limit
- Area 7 Deer Hill Road, First Street to Pleasant Hill Road
- Area 8 Hamlin Road/Sweet Drive, Solano Road to Doreen Way (note that some cracks on this street will require filling with 3/8" asphalt concrete hotmix)
- Area 9 Camino Diablo, Nogales Street to El Curtola Boulevard

SP7-02 SPECIAL PROVISIONS

Contractor's attention is directed to Section 2-2, "Examination of Documents and Site," of the Standard Specifications General Provisions.

St. Mary's Road (north) between Moraga Road and Hope Lane may have certain areas of the pavement marked for spot digout repairs. Typically these are rectangular areas marked in white paint. All cracks within such marked areas are not in the scope of this Contract.

Where a crack has previously been filled, and the old sealant has leached or been stripped away such that the resulting crevice is one-fourth (1/4) inch or more deep measured from the road surface, Contractor shall repair said crack as part of Contract Work. Additionally, all cracks that are filled, whether or not they have been previously filled, shall be filled flush to the top of the street grade. If crack fill material settles, the Contractor shall perform one of the following until the crack is filled to the top of the street grade:

- 1. Top off the roadway crack with additional filler, or other fillers approved by the Engineer in advance of their use.
- 2. For deeper cracks, backfill the crack with sand and then top off with additional filler.
- 3. For deep and wide cracks, tack coat the sides of the crack and fill with hand-tamped or vibraplated 3/8" asphalt concrete hotmix.

Contractor shall be solely responsible for furnishing the proper equipment to achieve results that comply with the Project Specifications. If in the opinion of the Engineer, the equipment being used by Contractor will not produce a conforming product, the Engineer shall have sole discretion to disallow the use of said equipment. If the Contractor insists on using the disallowed equipment, he shall do so at his own risk, and all work failing to meet the Project Specifications shall be rejected, and Contractor shall remove and replace said work at his sole expense. At his sole discretion, Engineer may allow non-conforming work to remain in place, but no payment for said work shall be due to Contractor.

City will furnish a certain amount of asphalt rubber crack sealant to be used by Contractor in the performance of Work. The product to be furnished by City is Duroflex Crack Sealant by Henry Hot Melt Products, approximately eleven (11) boxes, each containing a 35-pound block, able to provide 3.75 gallons of joint volume per manufacturer's data sheet. Contractor shall determine the amount required to complete Contract Work and furnish additional materials as required.

Sand used to cover sealant material per Section 12-2.2, "Asphalt Rubber Crack Sealant," of the Technical Provisions of the Standard Specifications shall be colored BLACK. Sand may be black "Kleen Blast" sand blast media available at White Cap Construction Supply (Concord, CA), or an approved equal.

SP7-03 MEASUREMENT AND PAYMENT

The contract lump sum price paid for "Crack Fill Repair" shall include full compensation for furnishing all labor, supervision, materials, tools, equipment and incidentals necessary to fill all cracks within the limits of pavement shown on the Plans in accordance to procedures specified in the Project Specifications, including but not limited to: mobilization; traffic control, construction signage, and arrow board; routing and cleaning cracks; tack coat binder; fillers of all kind; black sand; cleanup and sweeping; and all other work as specified in the Project Specifications, and as directed by the Engineer, and no additional compensation shall be allowed therefor.
