Ordinance 635

The City Council of the City of Lafayette does ordain as follows:

Section 1. Findings. The City Council finds the following:

WHEREAS, the Housing Element of the Lafayette General Plan was updated and approved in 2011 by the City Council; and

WHEREAS, the City's Housing Element includes a program to review the zoning regulations and consider revisions to governmental constraints on the development of housing. By defining the uses and identifying the locations where the uses are permitted the City is removing constraints to the development of housing; and

WHEREAS, providing housing to all segments of the population including those with supportive needs is outlined in the General Plan and the updates are consistent with the General Plan. While certain types of supportive care are currently allowed in all zoning districts, some of the specific types outlined in the California Health and Safety Code and Government Code are not included. The City is therefore amending the activity classifications and general provisions to include additional types of supportive care in all zoning districts in which residential dwelling units are a permitted use, which include the multifamily and single-family zoning districts, and business and commercial districts.

WHEREAS, California state law requires allowance of the proposed uses and the changes to the municipal code and zoning regulations are consistent with state law; and

WHEREAS, the City prepared Zoning Text Amendment ZT06-14 to amend Chapter 6-4 "Activity Classifications", Chapter 6-5 "General Provisions" and all of the zoning districts classified as single-family and multi-family, and business and commercial districts to define and allow "Foster home", "Group home", "Health care", "Senior residential care", "Supportive housing", and "Transitional housing"; and

WHEREAS, on September 2, 2014, the Planning Commission of the City of Lafayette conducted a duly noticed public hearing pursuant to Government Code section 65854, at which time all persons wishing to testify in connection with ZT06-14 were heard and ZT06-14 was fully studied and the Planning Commission adopted Resolution No. 2014-20 forwarding a recommendation of approval to the City Council; and

WHEREAS, on September 22 and October 14, 2014, the City Council of the City of Lafayette conducted a duly noticed public hearing pursuant to Government Code section 65854, at which time all persons wishing to testify in connection with ZT06-14 were heard and ZT06-14 was fully studied;

WHEREAS, all other legal prerequisites to the adoption of this Resolution have occurred.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF LAFAYETTE CITY COUNCIL THAT:

<u>Section 2. Zoning Text Amendment Findings</u>. Pursuant of Lafayette Municipal Code Section 6-213 and based on the entire record before the City Council and all written and oral evidence received at the public hearing on this matter, the City Council hereby makes and adopts the following findings:

- (a) The zoning text amendment is compatible with the General Plan and each of its elements and all components therein because the General Plan includes a stated goal to "adopt and implement a Housing Chapter that is in compliance with state law." (Goal H-5); and
- (b) The Amendment is compatible with the uses authorized in, and the regulations prescribed for, the land use districts for which it is proposed and with the regulations for each land use district; and
- (c) There is community need to amend the zoning text to allow supportive care in all zoning districts in which residential dwelling units are a permitted use in order to provide housing for all segments of the community and to comply with state law.

<u>Section 3. CEQA.</u> The City finds and determines with certainty that the amendments described in ZT06-14 are not considered a project under the Environmental Quality Act Sections 15061(b)(3) and 15378(b)(5) as the ordinance is an administrative activity that only implements existing state law and would not, itself, allow any construction or propose any projects, and each proposed project would be subject to individual CEQA review.

<u>Section 4. Adoption of Amendment.</u> Based on the record before the City Council, all written and oral evidence presented to the Planning Commission, and the findings made in this Resolution, the Planning Commission hereby recommends that the City Council approve ZT06-14 amending Chapter 6-4 "Activity Classifications", Chapter 6-5 "General Resolution 2014-20 Provisions", Chapter 6-7 "Single-Family Residential Districts", Chapter 6-8 "Multiple-Family Residential Districts" and Chapter 6-9 "Business and Commercial Districts" of the Lafayette Municipal Code, as described in Exhibit "A" attached hereto and incorporated herein by reference.

Section 5. Severability. If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance, or any part thereof is for any reason held to be unconstitutional, invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance or any part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance irrespective of the fact that one or more sections, subsections, subdivision, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective. To this end the provisions of this Ordinance are declared to be severable.

<u>Section 6. Public Records.</u> The location and custodian of the documents and any other material which constitute the record of proceedings upon which the City Council based its decision is as follows: City

Clerk, City of Lafayette, 3675 Mt. Diablo Blvd #210, Lafayette, CA 94549.

<u>Section 7. Publication</u>. The City Clerk shall either (a) have this Ordinance published in a newspaper of general circulation once within fifteen (15) days after its adoption, including the names of the city council members voting for and against its passage, or (b) have a summary of this Ordinance published twice in a newspaper of general circulation, once five (5) days before its adoption and again within fifteen (15) days after adoption, including the names of the city council members who voted for and against its passage.

Section 8. Effective Date. This Ordinance becomes effective thirty (30) days after its adoption.

Section 9. Certification. The City Clerk shall certify to the adoption of this Ordinance.

- (c) Health care The provision of residential care for six (6) or fewer patients for temporary rehabilitation of an injury or illness.
- (d) Senior residential care The provision of residential care for six (6) or fewer senior residents, 60 years or older and are in need of 24-hour care pursuant to Chapter 6-11.5 of the LMC.
- (e) Supportive housing The provision of residential care which includes supportive services that help residents improve their health and maximize their ability to live and work in the community and may include treatment for developmental disabilities, chronic illnesses, or substance abuse as further defined in the Government65582 and shall be considered a residential use of the property and subject only to the restrictions that apply to other dwelling units of the same type in the same zone.
- (f) Transitional housing The provision of residential care for a minimum of 6 months and a maximum of 2 years, for homeless individuals and families transitioning to permanent housing as further defined in the Government Code 65582 and shall be considered a residential use of the property and subject only to the restrictions that apply to other dwelling units of the same type in the same zone.
