Notice is hereby given that the **Draft Supplemental Environmental Impact Report (Draft SEIR)** for the **Terraces of Lafayette Project Alternative – "The Homes at Deer Hill" (Revised Project)** has been prepared and is now available for review

The **Draft SEIR** is a report that assesses the potential environmental consequences of approving the Terraces of Lafayette Project Alternative – "The Homes at Deer Hill." Additionally, the Draft SEIR identifies feasible mitigation measures and Revised Project alternatives that would reduce or avoid significant environmental impacts. The Draft SEIR is intended to inform decision-makers, other agencies, and the public of the nature of the Revised Project. The Draft SEIR has been prepared in accordance with the California Environmental Quality Act (CEQA). The City of Lafayette is the lead agency for the Project.

Project Description The proposed Revised Project would construct 44 single-family residences and a community park on a largely vacant 22.27-acre site. In addition, a dog park would be created on a 3-acre site on the north side of Deer Hill Road. The project would require a General Plan Amendment, Re-Zoning, Planned Unit Development, Hillside Development Permit, Land Use Permit, Design Review, Tree Removal Permit, Grading Permit, Subdivision, and Development Agreement.

<u>Project Location</u> The proposed Revised Project is located in the City of Lafayette, in central Contra Costa County. The Project site is located at 3233 & 3312 Deer Hill Road and in east central Lafayette, west of Pleasant Hill Road, and north of State Highway 24.

<u>Significant Environmental Effects</u> The Draft SEIR discusses significant environmental effects that could result from the Revised Project in the following categories: aesthetics and visual resources; air quality; biological resources; cultural resources; greenhouse gas emissions; hazards and hazardous materials; land use and planning; noise; and traffic and transportation.

<u>Project Alternatives</u> The Certified EIR for the Terraces of Lafayette Project analyzed three alternatives: No Project Alternative; Mitigated Project Alternative; and Office Development Alternative. The Draft SEIR analyzes an additional alternative – a Mitigated Revised Project Alternative.
