**Subject: 2019 Road Reconstruction Project, Number 014-9719**

Dear Residents:

The City of Lafayette has awarded a construction contract to Grade Tech Inc. to reconstruct six streets and courts in Lafayette. Please see the reverse side of this notice for the listing. On some streets the work will also include installation of new storm drains and replacement of curb and gutter improvements.

Work tentatively is scheduled to begin the week of June 18<sup>th</sup> with an anticipated completion date for the entire project in late September. Weekly updates of the project schedule will be posted on the City's web site at <http://www.ci.lafayette.ca.us> (select "Public Works & Construction Projects" in the quick links section on the left corner of the page; then select "City Construction Projects", and last select the 2019 Road Reconstruction Project, Project Number 014-9719).

The work will require closure of travel lanes with traffic control and road closures during certain phases of the reconstruction. Traffic control will generally be in effect between 8:00 am and 5:00 pm and road closures may be in effect between 8:30 am and 4:30 pm. Emergency vehicles will be provided access at all times. Please look for the "No Parking" signs posted on barricades at least 48 hours prior to construction activities. These signs will specify the dates and hours of restricted parking. It is imperative that no cars remain parked on the street in the posted area during the indicated date and time period. Additionally, signs will be posted alerting the public of the road closure days and times. If possible, please make arrangements to park outside the road closure limits or avoid the need to make vehicle trips during the closure hours.

The street work will require pruning all vegetation that encroaches into or overhangs the roadway to allow clearance for the construction equipment. Residents are encouraged to prune their own vegetation to one foot behind the back of curb or new planned edge of pavement and to 14.5 feet high over the road. However, the contractor will prune any vegetation left in conflict at the time of construction. Additionally, if you have any private improvements that are not readily visible or are located near the edge of the road or curb and gutter, and you are concerned that they may be damaged or removed during construction, please contact me so I can be aware of the improvement and discuss any options that may be available. The referenced improvements may include decorative rock, sewer or storm drain lines and cleanouts, irrigation and landscaping, fencing, etc.

Please keep in mind that street work often occurs in phases, and once work has begun, it does not necessarily proceed continuously. You will see periods of inactivity between the start and end of the project. The City and the contractor are anxious to complete this project with minimum delay and inconvenience to you. While the work is in progress, please lend us your cooperation and extra patience and be alert to equipment, workers, and traffic.
