



Dear Resident:

Pavement Coatings Company, under contract with the City of Lafayette, will be performing maintenance repairs on or near your street that will affect access to your street during construction. This work will be done in one or three distinct phases, depending on the design treatment for your street. Please see the enclosed work schedule indicating what work is planned for the streets. Please note that not all streets will receive all of the pavement preservation treatments. The hours of construction will be from 8:30 AM to 4:30 PM, Monday through Friday. Work will begin with crack filling, followed by pavement repairs, and a chip seal (not all streets will receive a chip seal) that will blanket the entire road surface with a mat of rubberized liquid asphalt and rock chips. All streets including the chip seal streets will receive a slurry seal as a final finish. Please note that the slurry seal can take up to 4 or 5 hours to dry sufficiently to allow cars to drive on it.

In order to provide the City and its residents with a better looking and longer lasting road, as well as provide the workers with a safe work environment, we ask that traffic closures be observed. During the chip and slurry seal process, all roads will be closed to traffic, except for Moraga Road, Silverado Drive, and Del Mar Drive, which will have one lane closed at a time. Properties off of roads scheduled for partial closures will have restricted access when their side of the street is sealed. Please see enclosed table for a listing of streets, dates of closures, and limits of work.

During the chip seal process 2-hour closures are anticipated. During the slurry seal process, access to properties on all streets, including streets receiving a partial closure, will be restricted for a period up to 5 hours. Non-emergency vehicles will not be permitted to drive across or on the wet slurry. The City will make arrangements for access by emergency vehicles. In the few days immediately following the chip seal, signs will be posted to advise motorists to reduce speed to avoid kicking up the loose rock chips that would be expected on the roadway. **Please note that if you live off a street that will receive a chip or slurry seal treatment your access will also be restricted.**

Barricades and traffic cones will be placed to prevent vehicles from entering the wet areas. Please do not go around the traffic control devices; chip and slurry seal are tar-like substances that can splash onto the sides of vehicles as well as track onto other surfaces such as driveways and sidewalks if driven through or walked upon while wet. If you do have oil on something, simple dish soap and water will clean the area if caught before the oil has had time to dry. Otherwise we recommend a citrus solvent-type cleaner.

Notification and no parking signs will be placed on the road a minimum of 3 days prior to the start of each phase of work. These signs will provide the roadwork dates when parking on the street will not be allowed. It is very important that our contractor's crews have access to the entire street. Please note that vehicles parked on the street blocking construction activities will be towed at the owners' expense. In order to sweep excess loose rocks after placement, we request that you park off the chip-sealed streets for two days following the placement of the chip seal.

In the event the contractor is unable to perform chip or slurry seal work on your street on the scheduled day, project information signs at the entrance to your street will be updated to provide the new date and times for the work.
